Please refer to office memo No no.676/PS/ACS(T)/2018, dated 20.02.2018(Copy enclosed again) vide which W/ACS(T), Govt. of Haryana had directed to provide requisite complete information along with an undertaking on affidavit within 7days regarding all transport/non transport vehicles which are being registered in your district are affixed with HSRP. Incompliance of the above this office has also directed to provide requisite information as desired by W/ACS(T), Govt. of Haryana vide memo no. 12257-12353/AT-I/ST-II, dated 27.02.2018 on the subject cited above.

Although some field offices have provided the information which is still incomplete and only partial information has been provided. In view of the above you are once again requested to ensure for providing the requisite complete information(Non-transport/Transport vehicles) along with an undertaking on affidavit within two days positively from the offices(i.e. SDO-(c)- cum Registering Authorities)under your jurisdiction being a Nodal officer and also from your side.

Please treat the matter as date bound as an affidavit is to be filed before the Hon'ble Supreme Court of India as well as in the Hon'ble High Court, at Chandigarh.
