 working experience of at least one year in a reputed automobile workshop which undertakes repairs of both llight motor vehicles, heav, goods vehicle and heavy passenger motor vehicles fitted with petrol and diesel engine; and

 must hold a driving licence authorizing him to drive motor cycle, heavy goods vehicles and heavy passenger motor vehicles.

## CONDITIONS

1. That there is nothing adverse about the integrity of the officials during the whole service.

2. That no chargesheet under rule 7, 8 or any criminal proceedings/court case is pending against them.

3. That on appointment in the Transport Department, their lien will remain intact in their parent department.
