Notification

No. 13/4/2013-3T(I).—In exercise of the powers conferred by Sub-section (1) read with Sub-section (2) of Section 65 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), and with reference to Haryana Government, Transport Department, Notification No. 13/4/2013-3T(I), dated 6th December, 2013, the Governor of Haryana makes the following rules further to amend the Haryana Motor Vehicles Rules, 1993, namely :—

Rules

1. These rules may be called the Haryana Motor Vehicles (Amendment) Rules, 2013.
2. In the Haryana Motor Vehicles Rules, 1993 (hereinafter called the said rules), in rule 33, in sub-rule (1), in the second proviso, for the figure "100", the figure "20" shall be substituted.
3. In the said rules, for rule 33A, the following rule shall be substituted, namely:-

"33A. Assignment of preferential registration numbers to motor vehicles.

Section 65(2)(b)(p)-(1) The following preferential registration numbers shall be assigned to the motor vehicles by the Registering Authority, on first come first serve basis, on payment of an additional fee by the owners of the motor vehicles, as mentioned below,—

(a) For Non-Transport Vehicles

Provided that the preferential registration numbers shall be assigned to the motor vehicles owned by the State Government without payment of the additional fee.

(2) The registration number once assigned to a motor vehicle shall not be changed:

Provided that the preferential registration number shall be allowed to be assigned to a new motor vehicle being registered for the first time owned by the same person on scrapping of his existing vehicle to which preferential registration number has been assigned, without payment of the additional fee".
