Subject:- Filling up the 07 posts of Motor Vehicle Officer (Enforcement) of Group-B in the Transport Department (Regulatory Wing) on Deputation Basis.

The applications are invited from eligible persons to fill up 07 vacant posts of Motor Vehicle officer (Enforcement) of Group-B in the Transport Department (Regulatory Wing) on deputation basis (at Field offices) for a period of one year in the pay scale of this post i.e. FPL-6 (35,400-1,12,400) having the following academic qualifications and experience:-

- (i) Graduation from any recognized university;
- (ii) Two years experience on an analogous post;
- (iii) Hindi or Sanskrit as one of the subject in Matric or Higher Education.

The terms and conditions of deputation will be the same as defined in Haryana Civil Services (General) Rules, 2016.

It is to clarify that the brief of duties to be conducted by the Motor Vehicle Officer (Enforcement) is as under:-

1. Checking of illegal plying of motor vehicles round the clock under various section of Motor Vehicle Act, 1988 and rule made there under.
2. Supervision of the office.
3. Signing Authority of Registration Certificate, Permit & Driving Licence etc. Where Assistant Secretary is not posted in the office.

Application of the candidate should reach the office by 30.11.2024 through proper channel.

- (i) Clear Photostat copies of ACRs/APARs duly attested by Group "A" officer.
- (ii) Integrity Certificate.
- (iii) Certificate confirming that no disciplinary/Vigilance case pending or being contemplated against the employee.
- (iv) A statement showing major or minor penalties, if any, imposed on the applicant during his/her service tenure.
- (v) Certificate of equivalence of pay scale in support of eligibility.

Application received after the closing date or without photo copies of ACRs/APARs duly attested by a Group "A" officer or without recommendation of the concerned office or found incomplete will be rejected. While forwarding the applications, it may be verified that the certificate and particulars furnished by the employee are correct in all respect.
