Subject: Fitment of rear marking plate and reflector on Transport vehicles.

Reference this office memo no. 59501-523/T-3/ST-II dated 18.11.2018 on the subject cited above.

It has been decided by the State Government that all Manufacturers who are a Company registered with the Registrar of Companies as per the Companies Act, 1956 (as amended) or not and their subsidiaries as well as authorized distributors/dealers having type approval from the testing agencies approved by the Government of India, as per rule 126 of the Central Motor Vehicles Rules, 1989 shall be eligible for fitment of retro-reflective tapes, rear marking plates and circular reflectors to the notified transport vehicles in the State of Haryana. Accordingly, the following revised eligibility criteria and procedure has been devised:-

Eligibility Criteria

- a. All the Manufacturers whose Company whether registered with the Registrar of Companies as per the Companies Act, 1956 (as amended from time to time) or not and their subsidiaries as well as authorized distributors/dealers and having type approval from the testing agencies approved by Government of India as per rule 126 of the Central Motor Vehicles Rules, 1989 shall be eligible for fitment of retro-reflective tapes, rear marking plates and circular reflectors to the notified transport vehicles in the State of Haryana.
- b. **Type Approval:**
 1. Type Approval Certificate and Conformity of production of retro reflective tapes (Red, Yellow and White), rear marking plates and circular reflectors manufactured by the Company should be tested by testing agencies approved by the Government of India like Vehicle Research and Development Establishment of the Ministry of Defence or Automotive Research Associates of India, Pune or other similar Institutes as notified under rule 126 of the Central Motor Vehicles Rules, 1989.
 2. The retro reflective tapes (Red, Yellow, and White), rear marking plates and circular reflectors should conform to the requirements of Annexure-4, 5 and 6 of AIS: 090-2005, AIS:57, AIS 89-2005, AIS 8339 and all the BIS specifications notified under the Bureau of Indian Standards Act-1986 (63 of 1986) and as per rule 104(A), (B), (C) & (D) of the CMVR-1989.
- c. Any manufacturer and their subsidiaries as well as Authorized Distributors/Dealers whose approval/operations with respect to retro tapes, rear marking plates and circular reflectors have been

suspended/cancelled/black listed by any State/Central Government and in case, at any time, the details/information provided by the manufacturer is found to be false, misrepresented or suppressed, shall not be allowed for affixing the reflectors on the motor vehicles in the State of Haryana.

- d. The Manufacturer and their subsidiaries as well as Authorized Distributors/Dealers must not have been prosecuted or convicted and no investigation should be pending against such manufacturer for infringement of Intellectual Property Rights of any third party or entity under the provisions of The Patents Act, Copyright Act and/or Trademark Act, as the case may be, with regard to retro reflective tapes, rear marking plates and circular reflectors being manufactured by it.

Procedure


1. Any manufacturer and their subsidiaries as well as Authorized Distributors/Dealers having the type approval certificates from the testing agencies approved by the Government of India, may submit the following details to the Transport Commissioner:-
 - (a) Name of the manufacturer and their subsidiaries as well as Authorized Distributors/Dealers.
 - (b) Name of the authorized testing agency.
 - (c) Type Approval Certificate with number and date along with its date of validity.
 - (d) Maximum rates per meter/unit including fitment charges.
2. The aforementioned details of the such manufacturers and their subsidiaries as well as Authorized Distributors/Dealers shall be communicated to all Motor Vehicle Registering Authorities in the State by the Transport Commissioner's office. This information will also be uploaded on the website of the Department for the information of transporters/general public.
 - i) The manufacturer and their subsidiaries as well as Authorized Distributors/Dealers having type approval from the testing agencies approved by the Government of India and details of which have been circulated to all Motor Vehicle Registering Authorities in the State and uploaded on the website of the department by the office of Transport Commissioner will affix the retro reflective tapes, rear marking plates and circular reflectors as per prescribed specifications and issue a fitment certificate thereof mentioning therein the vehicle registration number, name of the manufacturer/Authorized Distributors/Dealers, Type approval certificate number along with name of the testing agency and number and date of the receipt for fee charged.

- ii) Secretary, RTA concerned will put the details of these manufacturers and their subsidiaries as well as Authorized Distributors/Dealers of the retro reflective tapes, rear marking plates and circular reflectors on the notice board of the office for the information of all concerned.
- iii) Fitness certificate will be issued to the motor vehicles by the Board of Inspection after ensuring that the reflectors have been affixed in the prescribed manner and proper details have been given in the fitment certificate.

You are advised to ensure at the time of grant of fitness certificate that the reflective tapes/reflectors of prescribed standards manufactured by the firms, the details of which have been communicated by this office as mentioned above has been affixed on the transport vehicles.
