Subject: Directions of Hon'ble Supreme Court regarding implementation of High Security Registration Plates Project and coloured coded stickers in the State of Haryana.

As you know that the HSRP and hologram based colour coded stickers are to be mandatorily affixed on the vehicles registered in the State. Also, those vehicles which have been faded with HSRP or hologram based colour coded stickers is not affixed should also have to get re-affixed so as to have these in proper usable shape and will be having 12 digit laser codes as mandated under Rule 50 of CMVR,1989 and Motor Vehicles (New HSRP) order'2018 visible on the vehicle The Hon'ble Supreme Court of India is also closely monitoring the progress on the implementation of its directions as stated above. The state is bound to file the status report in the matters and has filed its affidavit to comply with the orders in next six months.

To facilitate the implementation of above directions, the State of Haryana, on its part, has appointed a concessionaire i.e. M/s Link Utsav Registration Plates Pvt. Ltd., New Delhi to affix the HSRP on all existing vehicles registered in the State prior to 01.04.2019. The transparency and ease of access needs to be ensured.

Further, in view of the special pandemic conditions created due to COVID-19 it has to be ensured that public/ vehicle owners are provided with online facilities to get the HSRP and Colour Coded stickers affixed without being forced to visit the RTA Offices. The directions were already issued in this regard in past vide endst no. 41361-480/AT-1/ST-II dated 22.06.2017 to the Concessionaire.

In this regard, the Concessionaire is directed to promote its online application portal www.hsrphr.com created for the purpose, so as the Vehicle Owners can directly get the ordering of HSRP on this portal without even visiting the HSRP collection centre and the HSRP/colour coded stickers can be affixed on the designated location of the vehicle owner or at the dealer point/RTO office whichever
