Further, in NCR areas (Notified areas) smoke emission norms as BS-III & IV as amended by the Government of India from time to time may be adhered to strictly. Further, the approval has been given on the following condition:-

That the registration of only those vehicles, which are meeting with BS-IV emission norms will be done in NCR districts of Haryana and the vehicles which are meeting with BS-III emission normas can only be registered in the districts, which are not falling in NCR region and as per norms prescribed by the Govt. of India."

All Registering Authorities of Haryana State are, therefore, requested to accept the above models for registration as a 'Transport vehicles' in the Haryana State subject to the fulfillment of the provisions of the Motor Vehicles Act, 1988 and rules framed thereunder.
