2. DIMTS gave a detailed presentation on the findings of their Audit Team which had audited the status of implementation of the Committee's directions in the State of Haryana. Each of their findings was discussed in detail and representatives of the Government of Haryana were asked to comment on each of them. The representatives of the Government of Haryana agreed with most of the findings of the DIMTS's Audit Team. However, they also expressed their reservations on some of the findings. The Committee directed the DIMTS to share the findings of their Audit Team with the Government of Haryana, obtain their feedback and make changes as necessary to the Draft Report on the basis of the feedback.

3. The Committee also desired that the DIMTS should make this presentation to the Haryana State Road Safety Council in their next meeting to apprise the Council members of the ground realities. The Committee also directed the Government of Haryana to ensure, in coordination with DIMTS, that the presentation takes place before 31st August, 2017 and make arrangements for the presentation as necessary.

4. The Committee also directed the State to send a report on the approach the State Government will adopt to address the deficiencies pointed out in the findings of the

DIMTS's Audit Team and fix a time frame for addressing and removing each item of deficiency. The report should be sent to the Committee by **15th September, 2017.**
