HARYANA: AGENDA FOR MEETING TO BE HELD ON 20.11.2019

1. Outstanding items:

- (i) Follow up on Lead Agency, State Road Safety Council and State Road Safety Fund.
- (ii) Annual targets and strategies for achieving targeted reduction in fatalities.
- (iii) Fatalities on roads under NHAI, PWD(NH), State Highways and Western Expressway and measures taken/proposed to be taken to reduce them.

2. Implementation of various provisions of the Motor Vehicle (Amendment) Act, 2019.

3. Additional Directions given by the Committee vide its letter dated 26th September 2018

- (i) Meetings and targets for District Road Safety Committees.
- (ii) Identification of vulnerable road segments & Black Spots; and measures taken/proposed to be taken to reduce fatalities.
- (iii) Preparation of a Scheme under Section 135 of MV Act.
- (iv) Establishment of Highway Patrol – prevention of traffic violations particularly over-speeding on Highways.
- (v) Procurement of equipment (Speed guns, Alcometers, Interceptors, CCTV Cameras etc.) and strengthening traffic police as per BPR&D norms.
- (vi) Enforcement particularly in respect of over speeding: Annual Targets for compliance of laws on helmet, seat belt, use of mobile phones, over speeding etc and strategies for achieving targets.
- (vii) Identification of junctions requiring traffic calming measures and the timeline for taking road safety measures on all identified junctions.
- (viii) Installation/repair of Crash barriers and their maintenance as per IRC standards.
- (ix) Identification of vulnerable bridges and timeline for their rectification and maintenance as per IRC standards.
- (x) Audit of roads where accidents occur the most.
- (xi) Over-loading of school buses.

- (xii) Training of staff of Lead Agency.
- (xiii) Training of persons handling equipments and maintenance.
- (xiv) Under age students driving motorized vehicles to and from school.
- (xv) Mapping of ambulances (both public and private) and availability of trained paramedics and required equipments in ambulances.
- (xvi) Advertisement, display and implementation of Good Samaritan Guidelines.
- (xvii) Setting up of at least one Trauma care center in each district.
- (xviii) Publication of annual accident and fatality data every year in a book form.
