Kindly refer to your email dated 1st July, 2015 furnishing the compliance report relating to the directions of the Committee on Road Safety sought by the Committee vide its letter dated 25th May, 2015.

2. The measures taken by you have been examined by the Committee in detail. The Committee has the following observations:

Item No.	Observation of the Committee
(i)	Noted. It may be ensured that the meetings of the State Road Safety Council are held at least twice a year and Minutes of the meeting and Action Taken Reports are sent to the Committee regularly.
(ii)	Intimate the time-frame when the required information in respect of black spots will be sent to the Committee.
(iii)	Noted. The Committee does not feel the need to link procurement of equipment to the filling up of posts. The State may take action on procurements of equipments. Expedite the process of filling up the sanctioned posts.
(iv)	Noted. Adequacy of manpower and equipments available with the State may be assessed and intimated to the Committee. Evaluation of treated accident prone points may also be carried out. Further, action in respect of the remaining points may also be taken and intimated to the Committee.

(v)	A timeframe for providing the details of traffic calming measures taken by the PWD (B&R) may be drawn and intimated to the Committee.
(vi)	Noted.
(vii)	The Committee desires a time frame (for removal of hoardings and objects on National/State Highways that obstruct driving or distract drivers) may be drawn and intimated to the Committee.
(viii)	Noted.
(ix)	Noted. Updated information may be furnished in regard to implementation of schemes sanctioned by MoRTH/MHA/MoH&FW.
(x)	Road Safety Action Plan be redrafted by 30th September, 2015 and forwarded to MoRTH with a copy to the Committee.
(xi)	Noted. A time bound programme may be drawn to remove all encroachments on roads falling in the jurisdiction of HUDA, Urban Local Bodies and PWD (B&R).

4. You are requested to kindly take action as advised above and forward a comprehensive compliance report to the Committee in respect of all the directions by 30th September, 2015.
